ORDINANCE SETTING PENALTY FOR ORDINANCE VIOLATIONS AND
AMENDING CERTAIN SECTIONS OF THE HAVEN TOWNSHIP ORDINANCES

The Board of Supervisors of the Township of Haven, Sherburne County, State of Minnesota, do hereby adopt the following ordinance:

Pursuant to Minnesota Statutes § 609.034, the penalty for any person violating any of the Haven Town Ordinances shall be guilty of a misdemeanor.

The following changes shall be made to the Haven Township Ordinances (additions shown in underline and deletions shown in ~~striketrough~~):

1. **Ordinance No. 400 – Penalties**, as amended by Ordinance No. 96-500, shall now state:

That any person violating any of the provisions of Haven Town Ordinances shall be guilty of a misdemeanor ~~and upon conviction thereof, shall be punished by a fine of not more than \$500.00 or by imprisonment for not to exceed 90 days or both; provided however that if a petty misdemeanor or other different punishment be prescribed for violation of a specific ordinance such provision shall govern the punishment for such violations.~~

2. **Ordinance No. 96-500 is repealed in its entirety.**

3. **Ordinance No. 2008-01 – Ordinance Regulating Town Road Right-of-Ways, paragraph 5**, shall now state:

Any person violating any provision of this Ordinance shall be found guilty of a misdemeanor. The Board shall notify the property owner of a violation of this ordinance, and the owner shall have a time determined by the Board of not more than 45 days to remove the obstruction from the right-of-way. The notice shall be sent to the owner of the parcel as stated in the records of the County Recorder/Registrar of Titles or County Auditor. It shall state the Town Board's requirement to remove the obstruction and provide a date by which the work must be completed. Any culvert installed without the Town Board's prior written consent, shall be considered a violation of this Ordinance.

4. **Ordinance No. 2008-02 – Road Design and Standards Ordinance, paragraph 7**, shall now state:

Penalty. Any person violating this ordinance shall be guilty of a misdemeanor ~~or defined by Minnesota Statutes.~~

5. **Ordinance No. 2011-01 – Regulating the Parking of Vehicles During Certain Months Within the Town of Haven, Section Three, Subd. 7**, shall now state:

Penalty. Any person violating this ordinance shall be guilty of a ~~petty~~ misdemeanor.




