**RESOLUTION VACATING EASEMENT**

WHEREAS, a proposal came before the Township Board, to vacate a drainage and utility easement located in a recorded plat known as Willow Pond Acres, Haven Township, Sherburne County, Minnesota, being described as follows, to-wit:

A 10 foot drainage and utility easement over, under and across the South 5.00 feet of Lot 2, Block 2, Willow Pond Acres, Haven Township, Sherburne County, Minnesota, according to the recorded plat thereof and the north 5.00 feet of Lot 3, said Block 2, less and except the West 10.00 feet of said Block 2, and the east 30 feet of said Lot 2, and the east 10.00 feet of said Lot 1

WHEREAS, the Township Board did find said vacation is beneficial to the public interest.

NOW, THEREFORE, be it resolved that:


1. It is found to be in the public interest that the drainage and utility easement across Willow Pond Acres, as described above, be vacated.
