### RESOLUTION SETTING FEE SCHEDULE

<b>ZONING ORDINANCE FEES</b>	
<b>Feedlot Inspection</b>	Town cost, plus \$35/hour plus mileage
<b>Interim Use Permits</b> -Interim Use Permit (IUP) -IUP Inspections	\$2,500 per application \$35 per hour plus mileage
<b>Ordinance Amendment</b>	\$2,500 per amendment
<b>Sign Permits</b>	\$100 per permit (On-Premise) \$250 per permit (Off-Premise)
<b>Sign Inspection</b>	\$50
<b>Board of Adjustment</b> -Variance -Appeal	\$2,500 per application \$1,500
<b>SUBDIVISION FEES</b>	
<b>Park Dedication Fee</b>	
<b>New Residential Lot</b>	\$800 per lot or 10% land area
<b>Registered Land Survey</b>	\$750 per application
<b>Subdivision Preliminary Plat Extension</b>	\$200 per application
<b>Subdivision Simple Plat</b>	\$2,500 per application
<b>Subdivision Standard Plat</b> -Preliminary Plat -Final Plat -Erosion Control Inspection Fee	\$2,500 application fee, \$50 per lot \$1,200 application fee, \$25 per lot \$300 inspection fee, \$20 per lot
<b>OTHER PERMITS AND INSPECTIONS</b>	
<b>Driveway Permit</b>	\$200 plus \$35/hour plus mileage
<b>Gravel Mining Permit Monitoring Fee</b> (annual based on acreage)	\$15 per acre
<b>Storm Water Management and Erosion Control (MS4) Permit Application Fee</b>	\$1,000, plus Town costs
<b>Work in Right of Way Permit</b>	\$200 plus \$35/hour plus mileage
<b>Public Hearings</b> (meeting fee does not include application fees)	\$750 per special meeting
<b>Violation of Haven Town Ordinances</b>	Misdemeanor

In all cases, Town legal fees, engineering and surveying, additional staff, clerk or supervisor fees, and all other Town costs and fees must be paid prior to issuing any permit, signing any plat or before any Town action is effective. The Town may require an escrow payment to cover all costs and fees.


