WHEREAS, the expense of extinguishing a fire is a burden on the residents of the Town, and should be borne by those parties not complying with the law and obtaining a proper burning permit.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Haven, County of Sherburne, State of Minnesota, hereby adopts the following:

1. The Town shall charge the cost of the fire call, plus an administrative fee of \$15.00, for each fire extinguished for which no burning permit was obtained.


2. The owner of the property on which the fire originates shall be responsible for payment of this charge, and all payments shall be immediately due and payable.


3. The Town Clerk is hereby authorized and directed to send out all bills arising as a result of illegal fires as enumerated above.


4. Failure to pay said bills within 120 days will result in the Town submitting said bill to the Sherburne County Auditor to be certified for payment with real estate taxes.
